In completing this application form to be a member of the above club and by signing this form, I am declaring that I am not prohibited from possessing a firearm or ammunition by virtue of section 21 of the firearms act 1968 which sets out restrictions on the possession of firearms by certain categories of persons convicted of crimes in England, Wales and Scotland. In short, persons who are sentenced to a term of imprisonment or detention/custody at a young offender's institution of three years or more are never allowed to possess firearms, including antique firearms, or ammunition and persons who are sentenced to a term of imprisonment for three months or more but less than three years must not possess them until five years have passed since the date of release. Persons with suspended sentences of three months or more must not possess firearms, including antique firearms, or ammunition for a period of five years from the second day after the date on which sentence has been passed.

## Notes.

For **PROBATIONARY** members, the full fee is payable on application, and they may use the club ranges **ONLY** when accompanied by a **FULL** member. The acceptance of any fees does not guarantee that full membership will be accepted, or that any fees paid will be refunded.

**JUNIOR** members must be accompanied by a parent or guardian whenever they visit the ranges and the parent or guardian will remain present during the Juniors attendance at any of the clubs ranges.

All new members, unless they have a current F.A.C or are bona fide members of another recognised club, will remain probationary members for a minimum of 3 months. Probationers under 18 years will, after proving themselves competent, become a Junior member. Upon a juniors 18<sup>th</sup> birthday they will become a Full members. Probationers over 18 will, after proving themselves competent, become Full members.

## MEMBERSHIP FEES.

Probationary/Full member.....	£40.00 p.a. or part thereof.
Outdoor Only.....	£30.00 p.a. or part thereof

Juniors (under 18yrs) in any category.....	£10.00 p.a. or part thereof

Full membership offers full use of the club facilities for the main member and their family members. They may also be chosen to shoot for Fittleworth Rifle Club.

Outdoor only membership offers use of the outdoor range only. You must be a member of a recognised club that is Home Office approved and is affiliated to the N.S.R.A. these conditions also apply to any family members that you add. Any juniors in this category are the responsibility of the juniors club, or the individual detailed above as the responsible adult. The junior must be a member of a recognized club. The junior must be deemed by that club, capable to undertake shooting at the ranges involved.

All memberships fall due on the 1<sup>st</sup> January each year and must be paid by 31<sup>st</sup> January. A re-joining fee is payable by the main member for any subscriptions not received by the 31<sup>st</sup> January for the year due. This amount is in addition to the renewal fee and is double the main member's subscription.
